HAVE AGREED AS FOLLOWS

Art. 1 – Duration and Purpose

- 1.1. The coordinating body is responsible for the coordination and management of the RAY Network, the visibility of the Network, especially on European level, the dissemination of research results, the coordination of RAY Network-related meetings and other related conferences as well as serves as a communication point for the RAY Partners and the general public. Art. 2 – Financing

- 2.1. The partner agrees to make a financial contribution to the costs related to the activities and services described in the workplans in the amount of maximum **14.744,39 €**.
- 2.2. The calculation of the financial contribution is based on a flat fee (50%) and fee based on the size of the decentralised funds managed by the NA. The calculation overviews can be found in the internal area of the RAY website.

Art. 3 – Payments

- 3.1. The partner will pay the amount specified in article 2.1 within 30 days upon an invoice from the coordinating body.
- 3.2. The coordinating body reserves the right to not forward country specific results to the partner, as long as the partner has not paid the amount specified in 2.1. Further, the partner will not be mentioned in relevant publications, as long as the payment of the amount specified in 2.1. is not fulfilled.
- 3.3. The coordinating body reserves the right to impose penalty fees and interest according to Interest Act as well as take further legal actions in case the payment of the amount specified in 2.1. is severely delayed.

Art. 4 – Report

- 4.1. The coordinating body will provide report(s) to the network during the Network Meeting(s) and send a report a month after end date set out in Article 1.1.

Art. 5 – Data Protection

- 5.1. The partner agrees to provide it's personal data, namely "name", "address" and "bank data" for the purpose of contract performance. The data will be shared with the accounting department of the coordinating body. The data will not be shared with third parties.
- 5.2. The coordinating body and all partners are obliged to obtain the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation)

Art. 6 – Other provisions

- 6.1. The coordinating body commits itself to undertake the project in full respect of sound financial management, non-profit and procurement rules.
- 6.2. This agreement is governed by Finnish Law. Helsinki shall be the place of court for any disputes arising from this agreement.
- 6.3. The agreement shall enter into force on the date when the last of the two parties signs and when the Contribution Agreements of both NAs have been concluded. The electronic signatures are ensured through the VismaSign system.
- 6.4. Made in English language.
